- Comprises directional and non-directional investment strategies.

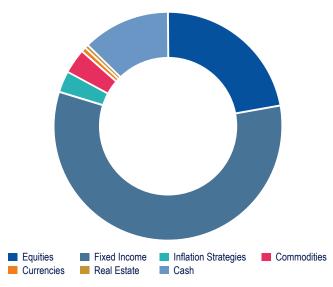
2 Stringent Risk Management

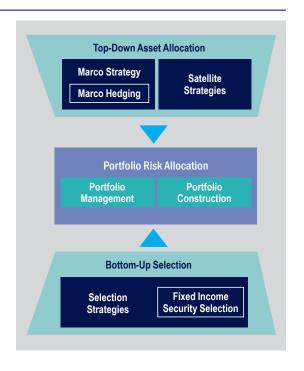
Investment Process

The Portfolio comprises multiple directional and non-directional strategies investing in traditional and non-traditional asset classes

Risk is allocated across Four Investment "Pillars" within a Risk Budgeting framework seeking "effective diversification"

Each "Pillar" attempts to deliver a unique contribution to overall portfolio risk and return.

Investment Pillar	Description	Average Number of Strategies
Macro Strategy	Scenario-based asset allocation reflecting our "Base Case" view of the world	15 – 25 strategies
Macro Hedging	Aims to protect the Portfolio against downside risks arising from alternative scenarios to our "Base Case"	5 – 10 hedges
Satellite Strategies	Multiple, low-correlated, relative value alpha-generating strategies	40 – 60 strategies
Selection Strategies	A basket of credit and sovereign issuers aiming to generate a stable yield and increase diversification	5 – 10 strategies investing across >200 issuers

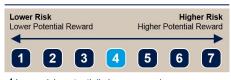
